Introduction

The Unified Planning Work Program (UPWP) outlines transportation studies and tasks carried out by Southwest Washington Regional Transportation Council (RTC) in FY 2024: July 1, 2023, through June 30, 2024. For a full understanding of the complete work of RTC, <u>RTC's website</u> is the best source for this information. The introductory page of the website includes links to monthly RTC Board packets, which provide planning study information and Board actions relating to the work of RTC during the fiscal year.

Work tasks listed in this document are based on the priorities set by the Region through the Regional Transportation Plan, by guidelines established under the federal metropolitan transportation regulations <u>23 USC 134</u>, and state requirements set forth in <u>RCW 47.80</u> and <u>WAC 468</u>.

RTC is required by <u>23 CFR 420.117</u> to report annually on UPWP progress. The UPWP Annual Performance and Expenditures Report summarizes progress made on approved UPWP tasks, programs, and planning activities. The performance and expenditures report includes:

- Comparison of actual system performance with established goals
- Progress in meeting schedules
- Budgeted funds compared to actual expenses
- Cost overruns or underruns
- Approved work program revisions

This element also addresses federal, state, and regional priorities and outlines tasks to develop regional multimodal transportation long-range strategies for the region and tasks that prioritize and program federally funded and regionally significant projects.

- Participated in the coordination with planning partners on the update of the Clark County Comprehensive Plan

2. Data Management, Travel Forecasting, and Technical Services

This element includes the development, maintenance, and management of the regional transportation database and website to support the regional transportation planning program. The database is used to monitor transportation system performance, to evaluate level of service standards, and to calibrate the regional travel forecasting model. This element also includes development and use of the regional travel forecasting model to estimate and analyze future transportation needs, air quality planning, and technical support to local jurisdictions.

3. Transportation Program Coordination and Management

This element provides for overall coordination and management required of the regional transportation planning program. Ongoing coordination includes holding regular RTC Board and RTAC meetings. It also provides for bistate coordination with Metro and ODOT to address both transportation and land use issues of bistate significance. In addition, this coordination and management work element provides for public participation activities, as well as federal and state transportation planning compliance.

A. Transportation Program Coordination and Management

Regional Transportation Program Coordination and Management

- Conducted meetings and prepared agenda and materials for monthly <u>RTC Board of Directors</u>, <u>Regional</u> <u>Transportation Advisory Committee</u> (RTAC), <u>Skamania</u> <u>County Transportation Policy Committee</u>, and <u>Klickitat</u> <u>County Transportation Policy Committee</u> meetings.
- Reviewed partner agency committee meeting agenda and materials and participated in meetings. These included Washington State Joint Transportation Committee meeting, quarterly MPO/RTPO/WSDOT Coordinating Committee, C-TRAN Board, Accessible Transportation Coalition initiative, CREDC Economic Development Partners, and Clark County Transportation Alliance.
- Participated in regional and statewide transportation committees and advisory boards, such as the statewide MPO/RTPO Coordinating Committee, the

state Commute Trip Reduction (CTR) program, WSDOT's TDM Technical Team, and specific modal plan studies as commissioned by WSDOT and other state agency partners
